For Coverage 4: Employees' Tools Coverage, MSRB/ISO is decreasing its current loss cost per \$100 of amount of insurance from \$3.30 to \$2.00. The proposed loss costs appear reasonable. Additionally, this filing is introducing cannabis related optional new exclusionary endorsements.
