ADMINISTRATIVE ORDER

THIS CAUSE came on for hearing before the Commissioner of Insurance of the State of Mississippi ("Commissioner"), by and through his specially designated appointee ("Hearing Officer"), in the offices of the Commissioner, 10th Floor, Woolfolk State Office Building, 501 North West Street, Jackson, Mississippi on Tuesday, April 9, 2019, at 10:00 a.m., pursuant to the Notice of Hearing and Statement of Charges mailed to Deandre Maze-Carter ("Respondent"), Non-Resident Insurance Producer License # 10431992. The Commissioner, by and through the designated Hearing Officer, having heard and considered all of the testimony and evidence produced by the parties herein, makes the following findings:

AUTHORITY

The hearing herein was held pursuant to the provisions of Miss. Code Ann. § 83-17-51, et seq. (Rev. 2011 & Supp. 2018), providing for the licensing of insurance producers by the Mississippi Insurance Department ("MID"), and specifically under Miss. Code Ann. § 83-17-71 (Supp. 2018), providing for disciplinary actions against producers.

NOTICE AND HEARING

1. A Notice of Hearing and Statement of Charges ("Notice") was sent to the Respondent via certified mail, regular mail, and email on or about February 25, 2019, at the addresses Respondent provided to MID. (Exhibit S-1)

- 2. In said Notice, Respondent was charged with violating Miss. Code Ann. § 83-17-71(1)(b), § 83-17-71(1)(i), § 83-17-65(1), and § 83-17-81(1) (Supp. 2018). (Exhibit S-1)
- 3. Pursuant to said Notice, a hearing was scheduled for and was held at 10:00 a.m. on April 9, 2019.
- 4. Respondent did not appear for the hearing.

FINDINGS OF FACT

- 1. Respondent had his insurance producer licenses revoked or suspended in the following states and in the following months, and the Respondent failed to report these administrative actions to MID (Exhibit S-2):
 - Utah License Revoked August of 2018
 - Indiana License Suspended August of 2018
 - Nebraska License Revoked December of 2018
 - Washington License Revoked December of 2018
- 2. Respondent's resident insurance producer license in Respondent's home state of Arizona expired as of December 31, 2018 and has not been renewed. (Exhibit S-3)

CONCLUSIONS OF LAW

Respondent violated Miss. Code Ann. § 83-17-71(1)(i) and § 83-17-81(1) (Supp. 2018) by having insurance producer licenses, or its equivalent, denied, suspended or revoked in other states, and by failing to report to the commissioner the administrative actions taken against the Respondent in other jurisdictions within thirty (30) days of the final disposition of the matters.

Respondent also violated Miss. Code Ann. § 83-17-71(1)(b) and § 83-17-65(1) (Supp. 2018) by violating an insurance law of this state through failing to remain currently licensed as a resident in the Respondent's home state. Therefore, Respondent does not satisfy the statutory requirements to obtain or maintain a non-resident insurance producer license in this state.

These violations subject the Respondent to the various disciplinary actions set forth in Miss. Code Ann. § 83-17-71 (Supp. 2018).

ORDER

IT IS, THEREFORE, ORDERED that the Respondent's Non-Resident Insurance Producer License #10431992 is REVOKED.
