VOLUNTARY SURRENDER OF LICENSE

I, CHAUNCEY VAN NORMAN D/B/A VAN NORMAN HOUSE MOVERS, having been fully advised of the charges of possible violations of the Mississippi Code and my rights to a hearing as provided in Miss. Code Ann. §§ 75-49-13 and 75-49-19 (supp. 2015) and understanding that I am entitled to a hearing before the Commissioner of Insurance of the State of Mississippi to determine the reasonableness of the Commissioner's action, do hereby waive the right to a hearing and consent to voluntarily surrender my Mississippi Installer/Transporter License No. 10003253 to act as a Manufactured Home Installer and/or Transporter in the State of Mississippi, effective June 30, 2016 at 11:59 p.m. I further understand that I will be ineligible to reapply for licensure for a period of two years from the effective date of surrender of my license.

I also agree to cease and refrain from engaging in the construction, sale, transportation or installation of a factory-built home intended to be used for human habitation, until such time as I may obtain a license from the Commissioner of Insurance for the State of Mississippi as required by § 75-49-9 of the Mississippi Code of 1972, as amended, and I understand that if I do engage in such conduct, I will be in criminal violation of § 75-49-19(4) of the Mississippi Code of 1972 as Amended.

This Voluntary Surrender of License is in lieu of any other administrative action by the Mississippi Insurance Department related to this matter, and otherwise finally resolves this matter, however, any outstanding fees which are now due or may become due to the State Fire Marshal's Office as a result of my activities as an Installer / Transporter shall be unaffected by this agreement, and I am in no way relieved of any liability for such fees.
