Pursuant to Miss. Code Ann. §83-5-69 (Supp. 2008), "Any company that neglects to make and file its quarterly and annual statement within the time provided in this chapter **shall** pay to the Commissioner of Insurance One Hundred Dollars (\$100.00) for each day's neglect; and upon notice by the Commissioner to that effect, its authority to do new business **shall** cease while such default continues..."

### **STATEMENT OF CHARGES**

Your company's failure to file an Annual Statement in a timely manner constitutes a violation of Miss. Code Ann. §83-5-55 (Supp. 2008) and Miss. Code Ann. §83-5-69 (Supp. 2008).
