

VOLUNTARY SURRENDER OF LICENSE

I, Wayne Joseph Westbrook, II, having been fully advised that I face potential charges of possible violations of the Mississippi Code and being advised that I have a right to a hearing as provided in Miss. Code Ann. § 83-17-71 (1), (2) and (4), and understanding that I am entitled to a hearing before the Commissioner of Insurance of the State of Mississippi to determine the reasonableness of any such charges, do hereby waive the right to a hearing and consent to voluntarily surrender my Mississippi Privilege Tax License No. 9201765 to act as an insurance producer in the State of Mississippi, effective immediately. As the Designated Responsible Licensed Producer for Greater Home & Auto Insurance, LLC, a Mississippi Insurance Producer Entity, I consent to the voluntary surrender of said agency's Mississippi Privilege Tax License No. 15033012, effective immediately.

I agree to cease selling, soliciting or negotiating any insurance; procuring insurance obligations, making or causing to be made in any way, directly or indirectly, any contract of insurance; receiving or receipting for money on behalf of an insurer for insurance, or securing or aiding in the placement of any contract of insurance and to refrain from any licensed activities in the State of Mississippi, unless specifically authorized by MID.

As a condition to this voluntary surrender, I do hereby acknowledge and agree that I forfeit my right to apply for any license issued by the Mississippi Insurance Department ("MID") until such time as I have made full restitution to any and all consumers, brokers, insurance carriers, or any other person harmed by my actions. In furtherance of this condition, I agree to provide my complete cooperation to affected insurance brokers and insurance carriers, as well as MID.

I further acknowledge and agree, in both my individual capacity, as well as my capacity as the Designated Responsible Licensed Producer for Greater Home & Auto Insurance, LLC, that it will be necessary for my current book of business to be reassigned to other licensed agents and that I will make no objection to any reassignment of any part of my book of business that may have been directly or indirectly affected by the surrender of these two licenses.

This voluntary surrender of license is being tendered in lieu of other possible administrative action by the Department of Insurance of the State of Mississippi.
