(h) Major Alteration Permits:

There will be a \$100.00 fee for each additional alteration to the Department of Insurance for the permit. The maximum alteration fee per unit is \$500.00.

The final inspection will be billed directly by the inspection company to the elevator/escalator installers detailed.
