IN THE MATTER OF ELIBERTO GRACIA, JR: ACTION AGAINST INSURANCE PRODUCER LICENSE No. 10134093

FINDINGS AND ORDER

THIS CAUSE came on for hearing before the Commissioner of Insurance of the State of Mississippi (hereinafter "Commissioner"), by and through his specially designated appointee (hereinafter "Hearing Officer"), in the Office of the Commissioner, 10th Floor, Woolfolk State Office Building, 501 North West Street, Jackson, MS 39205, on Wednesday, March 6, 2013, at 09:30 a.m., pursuant to a Notice of Hearing and Statement of Charges mailed to Eliberto Gracia, Ir on February 6, 2013. The Commissioner, by and through the designated Hearing Officer, having heard and considered all of the testimony and evidence produced by the parties herein, makes the following findings:

Authority

The hearing was held pursuant to the provisions of Miss. Code Ann. § 83-17-71, et seq. (Rev. 2011), providing for the licensing of insurance producers by the Mississippi Insurance Department, and specifically under Miss. Code Ann. § 83-17-71 (Rev. 2011), providing for disciplinary actions against producers.

Notice and Hearing

- 1. A notice of hearing was sent on February 6, 2013.
- 2. Pursuant to said notice, a hearing was scheduled for 09:30AM, March 6, 2013.

3. <u>Eliberto Gracia</u>, <u>Jr</u> failed to appear at said hearing.

Findings of Fact

1. <u>Eliberto Gracia, Jr</u> Missouri Producer license was revoked on January 2, 2013, for violation of 20 CSR 100-4.100(2) (A) for providing materially incorrect information in the licensing application by failing to respond to an inquiry.

Conclusions of Law

- 1. Eliberto Gracia, Jr is in violation of Miss. Code Ann. § 83-17-71 (1) (i) (Rev. 2011).
- 2. Eliberto Gracia, Jr is in violation of Miss. Code Ann. § 83-17-81 (1) (Rev. 2011).
- 3. Said violations subject Ms. Gonzalez to the various disciplinary actions set forth in Miss. Code Ann. § 83-17-71 (Rev. 2011).

Order

IT IS, THEREFORE, ORDERED that Eliberto Gracia, Jr be fined \$250.00.
