CONSENT ORDER

THIS CAUSE was scheduled for hearing before the Commissioner of Insurance of the State of Mississippi, sitting in a special session in the offices of the Commissioner of Insurance of the State of Mississippi, 10th Floor, Woolfolk State Office Building, 501 North West Street, Jackson, Hinds County, Mississippi on Thursday, September 18, 2008, at 10:00 a.m. on a complaint filed against Peggy Magee ("Respondent"), to hear evidence concerning said complaint. The Commissioner of Insurance, having been informed that the parties have agreed to the following terms, hereby finds as follows:

NOTICE AND HEARING

T

That on or about August 7, 2008, the Commissioner of Insurance of the State of Mississippi, or his appointee, pursuant to Miss. Code Ann. § 83-39-17 (Supp. 2007), gave the required notice to the Respondent of the Commissioner's intention to hold a hearing for the purpose of reviewing the status of Respondent's Privilege License to operate as a Soliciting Bail Agent and Bail Enforcement Agent in the State of Mississippi.

Π.

That said Notice of Hearing and Statement of Charges was sent to Respondent by certified

mail, return receipt requested, in accordance with Miss. Code Ann. § 83-39-17 (Supp.2007), at the address Respondent provided to the Licensing Division of the Mississippi Department of Insurance.

Ш.

That pursuant to said Notice, a hearing was scheduled before the Commissioner of Insurance of the State of Mississippi, for 10:00 a.m., on Thursday, September 18, 2008. Prior to the hearing date, the Commissioner of Insurance was informed the parties had reached a settlement agreement, the terms of which are stated within this Consent Order.

FINDINGS OF FACT

The parties agree to the following Findings of Fact:

IV.

The Respondent did at one time have a felony conviction in the State of Louisiana. However, that felony charge had been expunged by Order of the 22nd Judicial District Court, Parish of St. Tammany, Louisiana, on August 12, 2008. As a result of the expungement, the Respondent is not in violation of Miss. Code Ann. § 83-39-3(2).

V.

The Respondent was also charged with a violation of Miss. Code Ann. § 83-39-15(1)(c), in that she made material misstatements and misrepresentations in obtaining her bail agent's license, specifically, she did not inform the Department of her felony conviction. At the time she completed her license renewal application, the felony conviction had not been expunged; therefore, she is in violation of Miss. Code Ann. § 83-39-15(1)(c).

CONCLUSIONS OF LAW

IN LIGHT OF THE AFOREMENTIONED Findings of Fact, the Commissioner of

Insurance finds that Respondent, Peggy Magee, has committed the following violation:

VI.

That the Respondent, Peggy Magee, has violated the provisions of Miss. Code Ann. § 83-39-15(1)(c) (Supp. 2007), as she has made a material misstatement or misrepresentation in obtaining her bail agent's license.

ORDER

IT IS, THEREFORE, AGREED AND ORDERED that the Respondent, Peggy Magee, has violated Miss. Code Ann. § 83-39-15(1)(c), and therefore said charge should be and the same are hereby sustained.

IT IS FURTHER AGREED AND ORDERED, that the Respondent shall be assessed an administrative penalty in the amount of Two Hundred Fifty Dollars (\$250.00) to be paid to the Department of Insurance within thirty (30) days of the date of this Order. Her privilege license number 411818 to act as a Soliciting Bail Agent and Bail Enforcement Agent shall remain in effect.
