VOLUNTARY CONSENT TO ADMINISTRATIVE PENALTIES

I, LEO PATRICK FLEMMING, JR., having been fully advised of charges of possible violations of the Mississippi Code and my right to a hearing as provided in *Miss. Code Ann. § 83-17-71 and § 83-17-519 (Rev. 2022)* and understanding that I am entitled to a hearing before the Commissioner of Insurance of the State of Mississippi to determine the reasonableness of the Commissioner's action, do hereby waive the right to a hearing and consent to voluntarily accept the imposition of the following administrative penalties:

1. I agree to the imposition of a civil penalty in the amount of Two Thousand Dollars (\$2,000), payable to the "Mississippi Department of Insurance" (MDOI), which shall be immediately due and payable in full upon acceptance of this agreement by the Commissioner of Insurance.
2. I agree to waive, release, and cease any further efforts to collect those sums represented through invoice submitted to the City of Anguilla, dated November 6, 2023, as alleged "expenses" incurred by me. I will provide the City of Anguilla with notice of my release of this claim and provide the MDOI with a copy of said notice, all within 7 days of the effective date of this document. Furthermore, I agree to hold the "General Services Agreement" dated August 8, 2022; entered into with the City of Anguilla, to be null and void.
3. I agree that my Mississippi Insurance Producer and Public Adjuster License(s) # 10099422 shall be placed into probationary status for a period of one (1) year from the effective date of this instrument, and that the continuation of my license(s) in good standing shall be conditioned upon compliance with the terms of this instrument and my future compliance with the insurance laws of the State of Mississippi, including but not limited to compliance with all of the contractual and ethical requirements for public adjusters contained in *§ 83-17-523 (Rev. 2022)* (*Written contract required; compensation; cancellation of contract; ethical requirements*).

This Voluntary Consent to Administrative Penalties is tendered in lieu of other possible administrative action by the Mississippi Department of Insurance. I understand that the acceptance of this agreement by the MDOI shall only apply to violations of law now known to MDOI, and that my violation of the terms hereof may result in the initiation of further administrative action against me. This document shall be effective immediately upon its acceptance by the Commissioner of Insurance, as reflected by his signature herein below.
