## CONSENT TO ADMINISTRATIVE PENALTY

This Consent Agreement is being tendered in lieu of other possible administrative action by the State Fire Marshal for the State of Mississippi.

Quality Alarm & Security, LLC fully understands that should it fail to follow the terms of this Consent to Administrative Penalty that an administrative hearing may be set by the State Fire Marshal and administrative action may be taken as provided in the Mississippi Code, and that in such circumstances, no potential remedies shall be considered waived hereby.
